Failure to complete Code of Ethics training during any cycle will lead to <u>suspension of</u> <u>membership</u> for the January and February immediately following the cycle deadline, with termination of membership starting March 1 after the cycle deadline.



Licking County Home Sales Stay Strong Headed into Fall

Licking County's average home sold price was \$176,352 fromJanuary through September of this year, up 4.5% over the first nine months of2015. There were 1,890 existing homes and condominiums sold in this year's firstnine months, up 7.2% from the same period last year when there were 1,763 homessold, according to the Columbus REALTORS Multiple Listing Service.
