Finally, I consent that and authorize the Board, through its Membership Committee or otherwise to invite and receive information and comment about me from any Member or other person. I agree that any information and comment furnished to the Board by any Member or to his/her person in response to any such invitation, shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.

NOTE: Applicant acknowledges that if he/she is accepted as a member and then subsequently resigns or is expelled from membership in the Board due to an ethics complaint or arbitration request pending; The Board of Directors may issue a conditional renewal of membership upon applicant's verification that he/she will follow the pending ethics or arbitration proceeding, and will abide by the decision of the Hearing Panel. If in arbitration, the Board of Directors may issue a conditional renewal of membership. This conditional renewal of membership may be issued upon payment of the award, plus any costs that have been previously established as due and payable in relation to the complaint. This will take place providing the award and/or any other costs due to the complaint have not been otherwise satisfied in the interim.
